Ordinance No. 19 _____ 20 18

ORDINANCE REPEALING ORDINANCE 66-2000, AS AMENDED, WHICH PROVIDED FOR HEALTH CARE INSURANCE FOR RETIREES, EMPLOYEES WHO ARE NO LONGER EMPLOYED WITH THE CITY DUE TO DISABILITY, AND EMPLOYEES WHO HAD COMPLETED A CUMULATIVE TOTAL OF TWENTY (20) YEARS OF HONORABLE SERVICE, AND DECLARING AN EMERGENCY

WHEREAS, the City of Norwood desires to repeal Ordinance 66-2000, which established a program for healthcare for retirees, former employees who were no longer employed due to disability, and employees who had completed a total of twenty years of honorable service; and

WHEREAS, Ordinance 66-2000 was enacted to replace provisions in previous retiree health care Ordinances (which were repealed by Ordinance 67-2000) as a prudent response to changed circumstances, and

WHEREAS, the City of Norwood plans to enact a new Retiree Benefit Program for the years 2019 and thereafter; now therefore,

BE IT ORDAINED by the Council of City of Norwood, State of Ohio:

SECTION 1. Ordinance 66-2000, titled "Ordinance Providing Health Care Insurance for Retirees, Employees Who Are No Longer Employed with the City Due to Disability, and Employees Who Have Completed a Cumulative Total of Twenty (20) Years of Honorable Service, as Amended" is hereby repealed, effective December 31, 2018.

SECTION 2. This Ordinance is hereby declared to be an emergency ordinance and a measure necessary for the immediate preservation of the public peace, health, safety, and general welfare and shall go into effect forthwith. The reason for said emergency is the need to transition to the new program before the end of 2018.
