

Ordinance No. 8 20 18

ORDINANCE AUTHORIZING THE SERVICE-SAFETY DIRECTOR TO ENTER INTO A CONTRACT WITH RUMPKE OF OHIO, INC. TO PROVIDE FOR THE COLLECTION AND MANAGEMENT OF REFUSE, RECYCLABLES, AND YARD WASTE FOR THE CITY OF NORWOOD FOR CALENDAR YEARS 2018, 2019 AND 2020, AS WELL AS FOR OPTION YEARS 2021 AND 2022, AMENDING ORDINANCE 38-2017, AND DECLARING AN EMERGENCY.

WHEREAS, the City of Norwood's contract, providing for the collection of garbage and other waste throughout the City of Norwood has recently expired;

WHEREAS, in order to comply with Ohio law, the City of Norwood has advertised for bids, received bids, and opened those bids on November 22, 2017 and Rumpke of Ohio, Inc. was the lowest and best bidder to enter into a new contract to provide for the collection of garbage and other waste throughout the City of Norwood;

WHEREAS, the City of Norwood has determined that the Refuse Collection Fund 51 is the most appropriate fund from which to draw, and pay warrants in the amounts specified in the new contract, rather than from the General Fund 01, as ordained in Ordinance 38-2017, now therefore,

BE IT ORDAINED by the Council of the City of Norwood, State of Ohio, that:

SECTION 1. The Service-Safety Director is hereby authorized to enter into a new contract with Rumpke for the collection and management of refuse, recyclables, and yard waste throughout the City of Norwood for the years 2018, 2019 and 2020, as well as options for years 2021, and 2022, in accordance with specifications on file in the office of the Service-Safety Director, and consistent with Rumpke of Ohio, Inc.'s bid, a copy of which contract is attached as Exhibit A.

SECTION 2. The City Auditor is hereby authorized to draw and the City Treasurer is authorized to pay warrants in the amounts stated in the contract, out of the **REFUSE COLLECTION FUND 51**.

SECTION 3. This ordinance is hereby declared to be an emergency ordinance and a measure necessary for the immediate preservation of the public peace, health, safety, and general welfare and shall go into effect forthwith. The reason for said emergency is the necessity to proceed to have a new contract in place upon the expiration of the short extension of the previous contract.


