



Ordinance No. 28 20 19

**ORDINANCE AMENDING NORWOOD CODIFIED ORDINANCE §351.03 — PROHIBITED STANDING OR PARKING PLACES**

WHEREAS, in Ordinance 26-2006, Council amended Section 351.03 of the Norwood Codified Ordinances to generally prohibit parking on a street within three feet of a driveway; and

WHEREAS, it has come to the attention of Council that Section 351.03 was modified in the recent recodification to conform the Norwood Criminal and Traffic Codes to changes in state law since 2006; and

WHEREAS, the three-foot provision is not a part of state law, and was removed from Norwood's Code; and

WHEREAS, Council desires to include the three-foot limitation; now therefore,

BE IT ORDAINED by the Council of the City of Norwood, State of Ohio:

SECTION 1. That section §351.03(a)(2) - Prohibited Standing or Parking Places of the Norwood Codified Ordinances is hereby amended to provide:

(2) In front of, or within three feet of, a public or private driveway. If the vehicle being parked is owned by and registered to the owner of the private driveway, then such vehicle can be parked closer than three feet from the driveway, as long as the vehicle is not obstructing the driveway;

SECTION 2. That all of the rest and remainder of Norwood Codified Ordinance §351.03, not specifically amended by this Ordinance, shall remain in full force effect as heretofore enacted.
