Ordinance No. 1 20 20

**AN ORDINANCE AUTHORIZING THE SAFETY-SERVICE DIRECTOR TO ENTER INTO A CONTRACT WITH A QUALIFIED ENGINEERING FIRM TO COMPLETE A STUDY OF THE ELM AVENUE STORM SEWER SYSTEM, DESIGN AN IMPROVEMENT PLAN, AND HELP THE CITY IDENTIFY FUNDING SOURCES TO MAKE IMMEDIATE NEEDED IMPROVEMENTS, AND LONG-TERM SOLUTIONS, TO THE STORMWATER ISSUES IN THE AREA**

**WHEREAS**, the City of Norwood Council desires to work quickly to eliminate any future flooding issues in the Elm Avenue area; now, therefore,

**BE IT ORDAINED** by the Council of the City of Norwood, State of Ohio, that:

**SECTION 1.** The Safety-Service Director is hereby authorized to enter into an agreement with a qualified local engineering firm for the completion of an engineering study, with recommendations for immediate action items to minimize, as much as possible, flooding as well as provide engineering details and a plan to remove this stormwater problem and to help the City identify funding sources both to make immediate needed improvements and long-term solutions to the stormwater issues in that area of the City. City Council approves up to \$20,000.00 for the engineering study.


**SECTION 2.** The City Auditor is hereby authorized to draw and the City Treasurer to pay warrants totaling up to \$20,000.00 for the foregoing engineering study to the Elm Avenue area storm water sewer system out of the **STORMWATER FUND 62**.




