Ordinance No. 1 20 16

**ORDINANCE AUTHORIZING THE DIRECTOR OF SERVICE-SAFETY OF THE CITY OF NORWOOD TO ENTER INTO A CONTRACT WITH TA-TECH PLUS TO PROVIDE SERVICES TO THE CITY OF NORWOOD: OFFICE SERVICES TO THE CLERK OF COUNCIL, OFFICE SERVICES TO THE CIVIL SERVICES COMMISSION AND TIER I-IT TECHNICAL SERVICES FOR THE CITY OF NORWOOD, AND DECLARING AN EMERGENCY.**

**WHEREAS**, Norwood City Council desires to authorize the Director of Service-Safety to enter into a contract with TA-TECH PLUS to provide services to the City of Norwood: office and IT services to the Clerk of Council, office and IT services to the Civil Service Commission, and Tier I-IT technical services for the City of Norwood for the computer, printer, and telephone systems deployed within the City of Norwood, no more than forty (40) hours per week and receive \$18.00 per hour, for those services, beginning January 11, 2016; now therefore,

**BE IT ORDAINED** by the Council of the City of Norwood, State of Ohio, that:

**SECTION 1.** The Director of Service-Safety of the City of Norwood is hereby authorized to enter into a contract with TA-TECH PLUS, a sole proprietorship, to provide services to the City of Norwood: specifically, office and IT services to the Clerk of Council, office and IT services to the Civil Service Commission, and Tier I-IT technical services for the City of Norwood for the computer, printer, and telephone systems deployed within the City of Norwood, no more than forty (40) hours per week and to receive \$18.00 per hour, for those services, beginning January 11, 2016;


**SECTION 2.** The performance of this service contract shall not create any employment relationship with the City of Norwood, nor shall any actual service provider be entitled to receive any further benefit from the City of Norwood, nor shall the City of Norwood withhold any taxes from any payments under this service contract;

**SECTION 3.** Upon the termination of the contract referred to in this ordinance, the Council shall be authorized to immediately appoint a Secretary to the Clerk of Council to provide those services, who shall become an employee of the City of Norwood.

**SECTION 4.** The City Auditor is authorized to draw and the City Treasurer is authorized to pay warrants for the foregoing purposes out of the **GENERAL FUND**.


**SECTION 5.** This Ordinance is hereby declared an emergency. The reason for said emergency is the need to proceed forthwith.


