Ordinance No. 16 20 16

ORDINANCE PROMOTING THE "CITY WIDE STREET SALE" AND ABATEMENT OF ALL PERMIT FEES ASSOCIATED WITH THE SALE.

WHEREAS, Council desires to promote a semi-annual "City Wide Street Sale" to be held during the calendar year of 2016 on September 9th between the hours of 9:00 a.m. and 5:00 p.m. and September 10th between the hours of 9:00 a.m. and 5:00 p.m. and have all permit fees associated with the sale abated; now therefore,

BE IT ORDAINED by the Council of the City of Norwood, State of Ohio, that:

SECTION 1. The City of Norwood will have a "City Wide Street Sale" on September 9th between the hours of 9:00 a.m. and 5:00 p.m. and September 10th between the hours of 9:00 a.m. and 5:00 p.m. during the calendar year of 2016.

SECTION 2. Council for the City of Norwood hereby directs the Clerk of Council to advertise the "City Wide Street Sale" by postings throughout the City and Norwood Cable Television so as to notify residents of this upcoming event.

SECTION 3. Norwood City Council hereby authorizes the abatement of all permit fees associated with the "City Wide Street Sale" in order to promote this annual event.

SECTION 4. The City will prepare a directory showing the location of all participants in the "City Wide Street Sale."

SECTION 5. Street sale participants who obtain their permits seven days prior to the "City Wide Street Sale" will have their addresses included in a City directory of street sale locations. This does not prevent participants from obtaining a permit after the seven day deadline but participants who choose to do this will not be included in the directory.

SECTION 6. Council for the City of Norwood hereby authorizes each residence to have a yard sale in the front yard, side yard or back yard on September 9th between the hours of 9:00 a.m. and 5:00 p.m. and September 10th between the hours of 9:00 a.m. and 5:00 p.m.

SECTION 7. There will be no rain out dates scheduled to replace September 9th and 10th, 2016.

SECTION 8. No home sale/street sale shall be conducted by the same resident or member of his or her family and/or the same residential property more than twice in a twelve month period.

SECTION 9. No home sale shall offer any merchandise for sale that has been purchased by the resident for purposes of re-sale at such home sale. Any new merchandise offered for sale shall be prima-facie evidence of merchandise purchased by the resident for re-sale at such home sale.


SECTION 10. Whoever violates or fails to comply with any provision of this ordinance, shall be guilty of a minor misdemeanor.
