



Ordinance No. 6 20 16

ORDINANCE AUTHORIZING THE CLERK/TREASURER TO CERTIFY UNPAID BILLS FOR THE COST OF GRASS CUTTING TO THE HAMILTON COUNTY AUDITOR FOR FILING AS A LIEN ON THE TAX DUPLICATE OF THE OWNER(S) OF SAID PARCELS AND TO BE COLLECTED AS OTHER TAXES, AND DECLARING AN EMERGENCY.

WHEREAS, the Council for the City of Norwood desires to collect unpaid accounts of certain real property owners by placing a lien on the property; and,

WHEREAS, pursuant to the Ohio Revised Code, in order for the City of Norwood to collect payment of delinquent accounts by placing liens on the tax duplicate of the parcel of real property, Council must pass an ordinance authorizing unpaid accounts to be certified to the Hamilton County Auditor; now therefore,

BE IT ORDAINED by the Council of the City of Norwood, State of Ohio, that:

SECTION 1. Council for the City of Norwood authorizes the Clerk of Council/Treasurer to certify an unpaid bill in the amount of two hundred and twenty-one dollars and forty-five cents (\$221.45) for the cost of grass cutting to the Hamilton County Auditor to be placed as a lien on property at 2250 Buxton Avenue (Parcel Number 651-0010-0042-00). Said lien shall be collected as to other taxes.

SECTION 2. Council for the City of Norwood authorizes the Clerk of Council/Treasurer to certify an unpaid bill in the amount of two hundred and twenty-one dollars and forty-five cents (\$221.45) for the cost of grass cutting to the Hamilton County Auditor to be placed as a lien on property at 4217 Bell Street (Parcel Number 651-0051-0132-00). Said lien shall be collected as to other taxes.

SECTION 3. Council for the City of Norwood authorizes the Clerk of Council/Treasurer to certify an unpaid bill in the amount of two hundred and twenty-one dollars and forty-five cents (\$221.45) for the cost of grass cutting to the Hamilton County Auditor to be placed as a lien on property at 5112 Carthage Avenue (Parcel Number 651-0008-0159-00). Said lien shall be collected as to other taxes.

SECTION 4. Council for the City of Norwood authorizes the Clerk of Council/Treasurer to certify an unpaid bill in the amount of two hundred and twenty-one dollars and forty-five cents (\$221.45) for the cost of grass cutting to the Hamilton County Auditor to be placed as a lien on property at 5116 Carthage Avenue (Parcel Number 651-0008-0157-00). Said lien shall be collected as to other taxes.

SECTION 5. Council for the City of Norwood authorizes the Clerk of Council/Treasurer to certify an unpaid bill in the amount of two hundred and twenty-one dollars and forty-five cents (\$221.45) for the cost of grass cutting to the Hamilton County Auditor to be placed as a lien on property at 1917 Delaware Avenue (Parcel Number 651-0053-0101-00). Said lien shall be collected as to other taxes.

SECTION 6. Council for the City of Norwood authorizes the Clerk of Council/Treasurer to certify an unpaid bill in the amount of two hundred and twenty-one dollars and forty-five cents (\$221.45) for the cost of grass cutting to the Hamilton County Auditor to be placed as a lien on property at 5558 Laura Lane (Parcel Number 651-0004-0275-00). Said lien shall be collected as to other taxes.

SECTION 7. Council for the City of Norwood authorizes the Clerk of Council/Treasurer to certify an unpaid bill in the amount of two hundred and twenty-one dollars and forty-five cents (\$221.45) for the cost of grass cutting to the Hamilton County Auditor to be placed as a lien on property at 1732 Lincoln Avenue (Parcel Number 651-0049-0282-00). Said lien shall be collected as to other taxes.

SECTION 8. Council for the City of Norwood authorizes the Clerk of Council/Treasurer to certify an unpaid bill in the amount of two hundred and twenty-one dollars and forty-five cents (\$221.45) for the cost of grass cutting to the Hamilton County Auditor to be placed as a lien on property at 4712 Ridgeway Avenue (Parcel Number 651-0045-0148-00). Said lien shall be collected as to other taxes.

SECTION 9. This ordinance is hereby declared to be an emergency ordinance and a measure necessary for the immediate preservation of the public peace, health, safety, and general welfare and shall go into effect forthwith. The reason for said emergency is the necessity to proceed forthwith.
