**RESOLUTION CELEBRATING THE LIFE OF HELEN M. JASPERS. AND
DECLARING MAY 22, 2018, "HELEN M. JASPERS DAY"**

WHEREAS, Helen M. Jaspers was the Mother of Thirteen Children, Grandmother to Thirty-four Grandchildren, and a Great-Grandmother to Twelve Great-Grandchildren; and

WHEREAS, Helen M. Jaspers served in the City of Norwood Health Department for a quarter of a century, from 1978 until her retirement in 2003; and

WHEREAS, Helen M. Jaspers expressed a true compassion and kindness to the Citizens of Norwood, especially the financially less fortunate and homeless, earning the nickname, by her Colleagues, as the "Mother Theresa of Norwood", delivering food, sewing clothing, driving those who didn't have transportation to medical appointments, and many other acts of kindness and selfless generosity; and

SECTION 2. This Resolution designates May 22, 2018, as "Helen M. Jaspers Day".


