**RESOLUTION AUTHORIZING THE CITY AUDITOR TO APPROVE A "THEN AND NOW" CERTIFICATE FOR THE GENERAL FUND'S RECREATION KEY (01-1050) TO COVER THE COST OF AN INVOICE FOR UMC FOOD MINISTRIES FOR 2018 OF \$3,083.60, AND DECLARING AN EMERGENCY**

**WHEREAS**, the City Auditor has requested that the Council authorize the Auditor to approve a "Then and Now" certificate for 2019 for \$3,083.60 for the General Fund's Recreation key (01-1050) to cover the cost of an invoice for UMC Food Ministries, which provided lunch services to minor children participating in Norwood Recreation programming in summer 2018; and

**WHEREAS**, the invoice from UMC Food Ministries for 2018 services was not submitted to the City Auditor until 2019, so no purchase order was signed, and the \$3,083.50 amount of the invoice exceeds the \$2,500.00 limit for which the City Auditor can approve "Then and Now" certificates without this Council's approval; and

**WHEREAS**, in order to pay the 2018 invoice for the lunch services, the Auditor of State's office requires that the City of Norwood have a "Then and Now" certificate authorized by the Council; now therefore,

**BE IT RESOLVED** by the Council of the City of Norwood, State of Ohio, that:

**SECTION 1.** The City Auditor's office is hereby authorized to approve a "Then and Now" certificate for 2019 in the amount of \$3,083.50 for the **GENERAL FUND'S RECREATION KEY (01-1050)** to cover the cost of the invoice for UMC Food Ministries services in 2018.

**SECTION 2.** This resolution is hereby declared to be an emergency resolution and a measure necessary for the immediate preservation of the public peace, health, safety, and general welfare and shall go into effect forthwith. The reason for said emergency is the necessity to proceed forthwith to authorize payment of the invoice of UMC Food Ministries.
