



Resolution No. 18 20 16

RESOLUTION DECLARING COUNCIL'S SUPPORT FOR ISSUE 6, PROPOSED TAX LEVY RENEWAL FOR THE CITY OF NORWOOD, AND DECLARING AN EMERGENCY

WHEREAS, on April 26, 2016, Council for the City of Norwood voted unanimously to place a renewal of the current operating levy on the November 8, 2016, ballot; and

WHEREAS, the levy is a renewal of the existing operating levy, and not an increase or new levy; and

WHEREAS, Council decided to place the issue on the ballot this year, even though the levy does not expire until the end of 2017, in order to achieve a more stable basis on which to plan for the future; and

WHEREAS, the City's continuing status under Fiscal Watch and recent announcement of Fiscal Emergency status will require a formalized long-term financial plan; and

WHEREAS, passing the levy renewal now will be of great assistance in preparing long-term revenue projections and fiscal planning; therefore

BE IT RESOLVED by the Council of the City of Norwood, State of Ohio, that:

SECTION 1. The Council of the City of Norwood hereby expresses its support for the passage of Issue 6, Proposed Tax Levy Renewal, on the November 8, 2016, ballot as being in the best interests of the City of Norwood and its residents.

SECTION 2. This resolution is hereby declared to be an emergency resolution and a measure necessary for the immediate preservation of the public peace, health, safety and general welfare and shall go into effect forthwith. The reason for said emergency is that voting begins October 12, 2016.






