**RESOLUTION HONORING EAGLE SCOUTS
DEVON FALKENSTEIN AND BENJAMIN FANNING FROM
BOY SCOUTS OF AMERICA TROOP 9 IN NORWOOD**

WHEREAS, Devon Falkenstein and Benjamin Fanning, both from Troop 9 of the Boy Scouts of America, Dan Beard Council, founded in Norwood in 1915, have earned the rank of Eagle Scout this month; and

WHEREAS, each of these two Eagle Scouts earned well over the 21 merit badges required, and are among the 4% of Boy Scouts who have risen through the five other ranks of boy scouting to become Eagle Scouts; and

WHEREAS, these two Eagle Scouts exemplify the Scout Law by being Trustworthy, Loyal, Helpful, Friendly, Courteous, Kind, Obedient, Cheerful, Thrifty, Brave, Clean and Reverent; and

WHEREAS, these two Eagle Scouts planned, funded, staffed, and completed their Eagle capstone service projects by rebuilding both wooden trail bridges, 17 feet and 25 feet long, at the City of Norwood's Lindner Park McCullough Estate Nature Preserve at 2726 Cypress Way, projects which will benefit the people who use those trails for decades to come; and

WHEREAS, these two Eagle Scouts are a credit to their parents, Mark and Laura Falkenstein and Larry and Patty Fanning, to their families, to their Scout Troop 9, and to our community; and

WHEREAS, these two Eagle Scouts, after a rigorous board of review of their leadership, and service to Troop 9 and their community, were awarded their Eagle Scout rank at a Court of Honor ceremony on June 7, 2017 at Zion United Church of Christ;

BE IT RESOLVED by the Council of the City of Norwood, State of Ohio, that:

The Council congratulates Devon Falkenstein and Benjamin Fanning upon earning the rank of Eagle Scout and thanks them and Boy Scout Troop 9 for their Eagle projects rebuilding both wooden trail bridges at the City of Norwood's Lindner Park McCullough Estate Nature Preserve.


