A RESOLUTION AUTHORIZING THE MAYOR AND SERVICE-SAFETY DIRECTOR TO PREPARE AND SUBMIT AN APPLICATION TO PARTICIPATE IN THE OHIO PUBLIC WORKS COMMISSION STATE CAPITAL IMPROVEMENT AND/OR LOCAL TRANSPORTATION IMPROVEMENT PROGRAM (S) AND AUTHORIZING THE MAYOR TO EXECUTE CONTRACTS AS REQUIRED, AND DECLARING AN EMERGENCY.

WHEREAS, the State Capital Improvement Program and the Local Transportation Improvement Program both provide financial assistance to political subdivisions for capital improvements to public infrastructure, and

**WHEREAS**, the City of Norwood is planning to make capital improvements to various streets and infrastructure in need of repair, and

**WHEREAS**, the infrastructure improvements to be applied for, are considered to be a priority need for the community and is a qualified project under the OPWC programs,

Be it resolved by the Council of the City of Norwood, State of Ohio, that;

**SECTION 1.** The Mayor and Service-Safety Director are hereby authorized to apply to the OPWC for funds as described above.

**SECTION 2.** The Mayor is authorized to enter into any agreements as may be necessary and appropriate for obtaining this financial assistance.

**SECTION 3.** This resolution is hereby declared to be an emergency resolution and a measure necessary for the immediate preservation of the public peace, health, safety and general welfare and shall go into effect forthwith.
